M/S UMESH AGRAWAL AND ASSOCIATES, the Second Party, and represented herein by its Partner (hereinafter referred to as "Second Party", company which expression, unless excludedby or repugnant to the subject or context shall include its successors—in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as "Parties" and individually its 'Party') as

WHEREAS:

- A) First Party is a Higher Educational Institution named:
 - (i) G. S. SCIENCE, ARTS AND COMMERCE COLLEGE, KHAMGAON
- B) First Party and Second Party believes that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU foradvancing their mutual interests.
- E) M/S UMESH AGRAWAL AND ASSOCIATES, the Second Party is engaged in providing services as Chartered Accountancy firm.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

1.1. Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information.

- 1.2. First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry - the Second Party.
- 1.3. The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter here of and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2

SCOPE OF THE MOU

- 2.1 The budding graduates from the institutions could play a key role in technological upgradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 Curriculum Design: Second Party will give valuable inputs to the First Party inteaching / training methodology and suitably customize the curriculum so that thestudents fit into the industrial scenario meaningfully.
- 2.3 Industrial Training & Visits: Industry and Institution interaction will give an insightin to the latest developments / requirements of the industries; subject to the legal norms and internal office limitations, the Second Party to permit the Faculty and Students of the First Party to visit its group company's and also involve in Industrial Training Programs for the First Party. The industrial training and exposure provided to students and faculty
- a through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs

CLAUSE 3

INTELLECTUAL PROPERTY

A I Northing questioned in this MOU shall, by express grant, implication, Europpel or northing, create in either Party any right, title, interest, or license in or to the interestal property (including but not limited to know-how, inventions, patents,copy ingline and designs) of the other Party.

CLAUSE 4

VALIDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party onmutually agreed terms, during which period M/S UMESH AGRAWAL AND ASSOCIATES, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Anyact on the part of M/S UMESH AGRAWAL AND ASSOCIATES, the Second Party after termination of this Agreement by way of communication, second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
 - 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

CLAUSE 5

RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

- 2.4 Research and Development: Soft Parties have agreed to carry out the joint research activities in the areas of ACCOUNTANCY, ACOUTING AND TAXABLES AND ALLIED FIELDS

- 2.6 Great Lectures: Second Party to extend the necessary support to definer guest lectures to the students of the Pirst Party on the technology trends and in-house requirements.
- 2.7 Faculty Development Programm: Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.8 Placement of Trained Students: Second Party will try to actively engage itself is help the delivery of the training and placement of students of the First Party intointernships/jobs; and will facilitate placements for maximum possible number of the students. The Second Party at its discretion will itself absorb as many of the trained students as possible.
- 2.9 Both Parties to obtain all internal approvals, consents, permissions, and licenses of what so ever nature required for offering the Programmes on the terms specified termin.
- 2.10 There is no financial commitment on the part of the G. S. SCIENCE, ARTS AND COMMMERCE COLLEGE, KHAMGAON, the First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt with, separately.
- 2.11 The trainers may be paid by the Second Party a monthly stipend (so se decided later as per their norms) provided, they agree to be under staining for minimum of 35 hours in a week.

Any divergence or difference derived from the interpretation or application of the MOU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of KHAMGAON.
